

## EXTENSIVE INFORMATION ON THE USE OF COOKIES

ABS – Acciaierie Bertoli Safau S.p.A. – via Buttrio 28, 33050 Pozzuolo del Friuli (UD), Italy, in its capacity as **Data Controller**, reference is made to the legislation referred to in Article 13 of Legislative Decree 196/2003 (Personal Data Protection Code), the provision of the Privacy Authority for the protection of personal data "*Identification of simplified methods for the information and acquisition of consent for the use of cookies*" of 8 May 2014 and art. 13 of European Regulation no. 2016/679 (hereinafter "GDPR"), provides you with the following information regarding the cookies installed on the domain <https://www.absacciai.com> (hereinafter the "Site").

### WHAT ARE COOKIES?

Cookies are data created by a server and stored in text files on your computer's hard disk or on any device you use to access the Internet (smartphone, tablet) and allow us to collect information about your navigation on the website. Some of the purposes for installing Cookies may also require your consent.

Cookies can be stored permanently on your computer and have a variable duration (so-called persistent cookies), but can also disappear when you close your browser or have a limited duration (so-called session cookies).

Cookies may be installed by the site you are visiting (so-called first-party cookies) or may be installed by other websites (so-called third-party cookies).

### COOKIE USED AND THEIR PURPOSE

#### - **Activities strictly necessary for operation**

This site uses Cookies to save the user's session and to perform other activities that are strictly necessary for its operation, for example in relation to traffic distribution.

#### - **Preference saving, optimisation and statistics activity**

This site uses Cookies to save your browsing preferences and optimize your browsing experience. These cookies include, for example, those used to set the language and currency or for the management of statistics by the site owner.

#### - **Other types of cookies or third party tools that may use them.**

Some of the services listed below collect statistics in aggregated form and may not require your consent or may be managed directly by the owner, as described, without the help of third parties.

#### - **Statistics**

The services contained in this section allow the Data Controller to monitor and analyse traffic data and to keep track of the User's behaviour.

#### - **Third party services**

4. To enable cookies, the Privacy level must be set to "Medium" or below; setting the Privacy level above "Medium" will disable the use of cookies.

### Mozilla Firefox

1. Click on "Tools" at the top of the browser window;
2. select "Internet Options";
3. select the "Privacy" icon;
4. click on "Cookies";
5. select or not "Accept Cookies from Sites" and "Accept Third Party Cookies";

### Google Chrome

1. click the menu icon;
2. select "Settings";
3. at the bottom of the page, select "Show advanced settings";
4. in the "Privacy" section, select "Content settings";
5. select or not "Prevent sites from setting data".

### Apple Safari

1. click on the "Safari" label at the top of the browser window;
2. select the "Preferences" option;
3. click on "Privacy";
4. set your choice under "Cookies and website data".

## DATA TRANSFER OUTSIDE THE EUROPEAN UNION.

## DATA RECIPIENTS

The data may be processed by external parties acting as autonomous data **controllers** as, for example, supervisory and control authorities and bodies.

- a. companies offering e-mail services;

## DATA PROVISION OBLIGATION

The personal data processed through the installation of technical cookies and first party analytical cookies are necessary to ensure the correct navigation of the User within the site.

It is optional to consent to the installation of third party analytical cookies and profiling cookies. Your personal data will be processed through the installation of these cookies only with your express consent, as indicated above.

## RIGHTS OF THE DATA SUBJECT - COMPLAINT TO THE CONTROL AUTHORITY

By contacting the Data Protection Office, by post to the Company's address and by email to [dataprotection@absacciai.com](mailto:dataprotection@absacciai.com), the User may ask the Data Controller for access to data concerning them, its cancellation, correction or rectification of inaccurate data, the integration of incomplete data, the limitation of processing in the cases provided for by art. 18 GDPR, as well as oppose processing in cases of legitimate interest of the data subject. Furthermore, the User, in the event that the processing is based on consent or contract and is carried out by automated means, has the right to receive the data in a structured, commonly used and machine-readable format and, if technically feasible, to transmit it to another data controller without impediments.

Also as of 25 May 2018, in accordance with Art. 20 GDPR, the User may exercise, in addition to the above mentioned rights, the right to data portability. The data subject has also the right to receive his/her personal data in a structured format, commonly used and automatically readable, and has the right to transmit such data to another data controller.

Users have the right to lodge a complaint with the competent supervisory authority in the Member State in which they habitually reside or work or in the State where the alleged infringement has occurred.

## DATA CONTROLLER

Since the installation of Cookies and other tracking systems operated by third parties through the services used within this Application cannot be technically controlled by the Controller, any specific reference to Cookies and tracking systems installed by third parties is to be considered indicative only.
